Airborne Networks:

- **Coordinated w/LOS/BLOS for inclusion of TTNT into Annex K.**
- **Continue to work /SPINS and scheduling (Mark Johnson).**
- **Obtain OV-6C/SV-3 for completion of Link-16 architecture/OPTASK Link**
- **23 May – Initial network load will be released by network designers (USNE0005A JNL 115 Network 115)**

SATCOM:

- **Monday one request; now seven!**
- **23 May – Consolidated SAR/GAR submitted for EC08 by JFCOM**



Spectrum Issues/COMSEC

Frequency Management:

- **Monday had 8 sets of requirements; now 14.**
- **Many initiatives coordinating directly w/China Lake freq manager. Ensure you coordinate with JFCOM J6 for frequency requirements**
- **16 May – JFCOM submit all freq requirements for EC08**
 - **1 Jun approval for local approval by China Lake**
