Dear Madam, let me talk to you when you are alive before your demise. Let me be frank to you are the vest of Kenyans that I am a Kikuyu by tribe and have been in Kwikwe Sqd for four years and what I seen is untold suffering of Kikuyu youths in the hands of our officers who execute anyone suspected to be mungiki or robber but mostly must be a Kikuyu.

The aim of writing to you is not tell of what I have done or seen because even me I have killed 37 mungiki youth suspects and 5 robbers total 42 and these are now enough to me. Our Sgd is directly under the Commissioner of Police Maj Gen. Hussein Ali himself and is the one paying us 25,000/- each every week and we are 18 men now days. We were 33 men but others have died and others have disappeared from work. We are not allowed to go on transfer any other sector or division. Our Commanders is Mr Njiru senior SSP and Mr Richard Katola SSP and Mr George Mjoroge SSP. Mr Mjoroge is chief executor and has no mercy and himself alone has killed 14 mungiki and 25 robbers. We have our note books and we record everything.

In April 2009 Maj Gen Ali called all of us at night in his office and told us the Government had some special assignment for us and give us a list of wanted prominent persons and told us not to kill them until clear orders are given but he told to go and find all their details movements, homes, timings, hotels, roads they use, accomplices and be ready for action. No. 1 in the list was Paul Muite no. 2 was Ferdinand Wanjiku mp Embakasi no. 3, GS Kariuki no. 4 Bonny Khalwale mp no. 5 Gito by Manyara no. 6 Martha Karua no. 7 Mary Wambui and no. 8 Charles Kamau. Nsis was directed to write a report on these people. I knew what was to follow as we had already been directed to eliminate them. I passed information to Mr. Paul Muite and his outburst saved him because four men in our Sgd had been briefed secretly by Maj Gen Ali and Mr. John Muthaura and head of public service Mr Francis Muthaura to eliminate Muite and their commander Mr. Katola was each paid 150,000/- allowance and their commander Mr. Katola was paid 300,000/- but were later quickly called to abandon the mission when Muite went public to media.

We are told Sirse Lady Lucy Kibaki called Mr. Muthaura and Maj Gen. Ali and ask them to eliminate Muite. Nsis was pushing for the same. Things have + we were all called

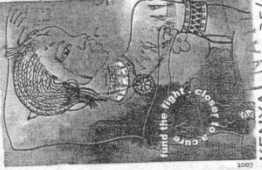

SSP and Mr. Mwachime his deputy until 11:00pm. When they came but our commanders did not tell what was discussed but add to us some money 10,000 each and divided us in four groups.
At midday today 14/6/09 my close friend in group one told me Mr. Richard Katola has briefed them that the Government has decided to go for Hon. Martha Karua and he came with a list of plan on how execute the mission.
Tasadhali madam utawawa just go away into exile because we know it will not take long for Maj Gen Ali to issue kill order. Mr. Muthaura, Mr. Michuki, Maj Gen Ali and Mrs Lucy Kibaki are the ones issuing orders to track prominent persons. Director General Nsis has issue a warning that the country may fall in darkness if we eliminate a prominent person this time but we carried Maj Gen Ali rehearsals on rich businessmen in Nairobi where we eliminated several but no much public outcry was noticed. Mr. Koki wa Mware is on 24 hours police watch. What is disturbing me is the way Mr Katola is torturing our youth before execution they are told to sing and sometime told to call Kibaki to come and rescue him. Now a days there is no use of ammunition or arms, we are using the methods used by Mungiki. We tie their necks, legs and hands and hang them on trees or even in cars until are dead. We take bodies to Emalissaro West Park for hyenas to eat and now days we are using Rural Sewage DAM to drop dead bodies at night. Mr. Richard Katola one day told us that Kikuyu askaris were used in Kakamega to kill his people and it his time to teach Kikuyu mungiki boys a lesson. Prof George Saitoti and his PS Mr. Kimemia are kept in darkness but only used to issue reports in Parliament and Public Barazas in support of Police without knowing they are being used. We told Mr. Mjoroge one day that our brothers are finished but he said what he wants is money and because we are really paid, then we keep quiet but we feel a lot of pain. Even President Kibaki is not aware of what is happening as upto now we have killed 1,839 mungiki suspects and 631 others suspected as robbers or carjackers and our all police officers in Kenya finds this Maj Gen Ali time very favourable for killing because he is encouraging all officers to kill robbers, thieves and mungiki on the spot and dont call media now days. Madam please you are dying. Pole sana mama - You are No.1 now the list of those under our eye. Yours saviour.
