- 1 We write further to our letter dated 6 July 2009.
- As you are aware, we are instructed by our client in relation to the publication on your website of a report ("the Report") and summary report ("the Summary") produced by the firm BDO Stoy Hayward in the context of a UK statutory inquiry involving our client (the "Inquiry") by the Tenant Services Authority (the "TSA")
- The TSA, having now completed the Inquiry, has decided that the Report should not be published for a number of reasons, including the fact that the Inquiry only relied on a limited number of the facts referred to in the Report, and that comments in the Report relating to individuals (including the Directors of our client) were clearly prejudicial.
- 4. The TSA concluded that the Report disclosed insufficient evidence to support a finding of misconduct in relation to any individual.

- 6 We have advised our client that it has a cause of action against all publishers of the Report (including the uploader, the host site and the domain host), as detailed in our previous letter.
