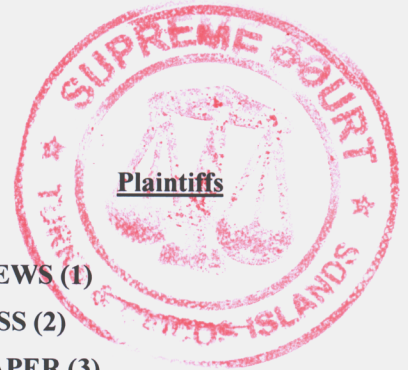

IMPORTANT:

NOTICE TO THE DEFENDANTS

- (1) This Order prohibits you from publishing in legible or audible form or in any form which may be edited, copied and viewed any redacted part of the Report of the Turks and Caicos Islands Commission of Inquiry 2008- 2009 until 5.00pm on Monday July 20th, 2009 or sooner order. You should read it all carefully. You are advised to consult an attorney as soon as possible. You have a right to ask the Court to vary or discharge this Order.

- (2) **IF YOU DISOBEY THIS ORDER YOU MAY BE HELD TO BE IN CONTEMPT OF COURT AND MAY BE IMPRISONED, FINED OR HAVE YOUR ASSETS SEIZED**

- (3) **ANY OTHER PERSON WHO KNOWS OF THIS ORDER AND DOES ANYTHING WHICH HELPS OR PERMITS A BREACH OF THE TERMS OF THIS ORDER MAY ALSO BE IN CONTEMPT OF COURT AND MAY BE IMPRISONED, FINED OR HAVE THEIR ASSETS SEIZED.**

The Defendants, their servants or agents are restrained from publishing in legible or audible form or in any form which may be edited, copied and viewed any redacted part of the Report of the Turks and Caicos Islands Commission of Inquiry 2008- 2009 until 5.00pm on Monday July 20th, 2009 or sooner order.
